On Saturday, April 21, 2012, the Women's Center of San Joaquin County will host its **5th Annual Walk A Mile in Her Shoes® International Men's March to Stop Rape, Sexual Assault & Gender Violence** on Pacific Avenue in Stockton's Miracle Mile. The walk will begin and end at Tuxedo Court. Walk a Mile in Her Shoes® challenges men to walk one mile in a pair of women's shoes to raise awareness and funds to support the Women's Center's services for sexual assault victims. The purpose of the march is to involve men in ending rape, sexual assault and gender violence. Proceeds from this event will help to support the Women's Center's sexual assault services.

Last year, more than 100 courageous men participated in the local march, helping to raise funds and awareness, and encouraging more men to speak out against rape and sexual assault. Some of the brave men included: Wes Rhea (Director, Stockton Convention and Visitor's Bureau); Sheriff Steve Moore (Sheriff's Department); Michael Mulvihill (Supervising Deputy District Attorney, Criminal Trial Division – San Joaquin County District Attorney's Office); Bill Trezza (CEO, Bank of Agriculture & Commerce); Stockton City Councilmember Elbert Holman; Stockton City Councilmember Dale Fritchen. The Women's Center anticipates even more walkers at this year's event.

- 1.) Create a fun opportunity to raise community awareness on a very serious issue: sexual assault.
- 2.) Raise funds to support the Women's Center's sexual assault services.
